

OPERATION AND MAINTENANCE AGREEMENT

THIS AGREEMENT made on April 13, 1987, is between the Soil Conservation Service, United States Department of Agriculture, hereinafter referred to as SCS, and the following organization(s), hereinafter referred to as the Sponsor(s).

The City of Pauls Valley

The Sponsor(s) and SCS agree to carry out the terms of this agreement for the operation and maintenance of the practice(s) in the State of Oklahoma. The practice(s) covered by this agreement are identified as follows:

Cherokee Sandy Creek Watershed, Site No. 17M

I. GENERAL

A. The Sponsor(s) will:

1. Be responsible for operating and performing or having performed all needed maintenance of practice(s), as determined by either SCS or the Sponsor(s), without cost to SCS.
2. Obtain prior SCS approval of all plans, designs, and specifications for maintenance work deviating from the O&M plan and of plans and specifications for any alteration to the structural practice.
3. Be responsible for the replacement of parts or portions of the practice(s) which have a physical life of less duration than the evaluated life of the practice(s).
4. Prohibit the installation of any structure or facility that will interfere with the operation or maintenance of the practice(s).
5. Notify SCS of any agreement to be entered into with other parties for the operation or maintenance of all or any part of the project practice(s), and provide SCS with a copy of the agreement after it has been signed by the Sponsor(s) and the other party.
6. Comply with the PROPERTY MANAGEMENT STANDARDS set forth in 7 CFR 3015.160-3015.175, and all applicable Federal, State, and local laws.
7. Provide SCS personnel the right of free access to the project practice(s) at any reasonable time for the purposes of carrying out the terms of the agreement.

B. SCS will:

1. Upon request of the Sponsor(s) and to the extent that its resources permit, provide consultative assistance in the operation, maintenance, and replacement of practice(s).

II. OPERATION AND MAINTENANCE PLAN (O&M PLAN)

An O&M plan for each practice(s) included in this agreement is attached to and becomes a part of this agreement.

III. INSPECTIONS AND REPORTS

A. The Sponsor(s) will inspect the practice(s) as specified in the O&M plan.

B. SCS or Federal land-administering agency may inspect the practice(s) at any reasonable time during the period covered by this agreement. At the discretion of the state conservationist, SCS personnel may assist the Sponsor(s) in inspections.

C. A written report will be made of each inspection and provided to others as outlined in the O&M plan.

IV. TIME AND RESPONSIBILITY

The Sponsor(s)' responsibility for operation and maintenance begins when a practice(s) is partially done or completed and accepted or is determined complete by SCS. This responsibility shall continue until the expiration of the evaluated life of all the installed project practice(s). This does not relieve the Sponsor(s)' liability which continues throughout the life of the measure or until the measure is modified to remove potential loss of life or property.

V. RECORDS

The Sponsor(s) will maintain in a centralized location a record of all inspections and significant actions taken, cost of performance, and completion date with respect to operation and maintenance. SCS may inspect these records at any reasonable time during the term of the agreement.

OPERATION AND MAINTENANCE PLAN
EROSION CONTROL MEASURES

I. OPERATIONS

A. The sponsor will be responsible for and will operate or have operated without cost to the Service the erosion control measures:

- (1) In compliance with any applicable Federal, State and local laws.
- (2) In a manner that will contribute to the measures serving the purpose for which installed as set forth in the Project Measure for this project.

B. The Service will, upon request of the Sponsor and to the extent that its resources permit, provide consultative assistance in the operation of the measures.

II. MAINTENANCE

A. The Sponsor will be responsible for and promptly perform or have performed without cost to the Service all maintenance of the measures determined by either the Sponsor or the Service to be needed. This decision will be made jointly between the Pauls Valley Municipal Authority, Garvin County Conservation, District Directors, and the technical representative of the Soil Conservation Service. Maintenance items that may need to be performed annually are as follows:

1. Weed Control
2. Fertilization
3. Additional fill material and/or topsoil if needed
4. Concrete liner repair if needed
5. Revegetation, if needed

B. The Service will, upon request of the Sponsors and to the extent that its resources will permit, provide consultative assistance in the preparation of plans and specifications for maintenance of the measures.
